I certify that the named student(s) on this application is/are not receiving Empowerment Scholarship Account (ESA) money from the Arizona Department of Education and is not applying for an ESA from the Arizona Department of Education. A student receiving ESA money from the Arizona Department of Education cannot receive any funds from any school tuition organization for that same academic year.

6. I understand that JETCO pays only a portion of the total tuition for each student.
